



# Pretty's Prime Cuts Members Rewards Program Terms and Conditions

1. In these Terms and Conditions:
  - **Pretty's Prime Cuts** refers to employees, agents, contractors, officers and related bodies corporate (as that term is defined in the Corporations Act 2001.)
  - There are three participating Pretty's Prime Cuts shops in the Pretty's Prime Cuts Member Rewards. They are:
    - **Pretty's Prime Cuts Fountain Gate**, Shop 2098, Level 2 Westfield Fountain Gate, 352 Princes Highway, Fountain Gate Vic 3805
    - **Pretty's Prime Cuts Werribee**, Shop T127 Pacific Werribee Shopping Centre, CNR Heaths and Derrimut Roads, Werribee Vic 3030
    - **Pretty's Prime Cuts Ocean Grove**, Shop 7-8 Ocean Grove Market Place, CNR Shell Rd and Kingston Downs Drive, Ocean Grove Vic 2720
  - **Card** refers to the Pretty's Prime Cuts Member Rewards Card issued in accordance with these Terms and Conditions.
  - **Cardholder** refers to a person who has applied for a Card and whose application has been accepted by Pretty's Prime Cuts.
  - **Programme** refers to the Member Rewards Programme run by Pretty's Prime Cuts.
2. By applying for the Card, the applicant agrees to be bound by these Terms and Conditions and any variations to them; agrees to participate in the Programme; and agrees to receive information and promotions via e-mail, and SMS/MMS (where such information has been provided by the Cardholder).
3. To apply for a Card and become a Member Rewards Cardholder, the person must:
  - Visit a Pretty's Prime Cuts store and register their name, email address and post code.
4. Pretty's Prime Cuts may, in its absolute discretion and without giving reasons for its decision, accept or refuse an application for a Card.
5. Cardholder benefits are determined by Pretty's Prime Cuts from time to time and may include discounts for products purchased at participating Pretty's Prime Cuts stores.
6. The rights &/or benefits of a Cardholder are non-transferable and not redeemable for cash.
7. Pretty's Prime Cuts may, in its absolute discretion and without giving reasons for its decision, at any time substitute advertised discounts for any other item of a comparable value or amend or withdraw any promotions.

8. Pretty's Prime Cuts shall not be liable in any way if benefits or promotions are unavailable as a result of a technical malfunction, operator fault, and errors resulting from computer hardware or software errors or failure.
9. All discounts for Cardholders for purchases at Pretty's Prime Cuts stores are subject to availability.
10. A Cardholder must produce their Card if seeking the benefit of any discount or other benefit offered to Cardholders or upon request by Pretty's Prime Cuts.
11. Pretty's Prime Cuts does not warrant in any way that the discounts or benefits for Cardholders will be available at any particular time or times or in any particular stores.
12. Cardholder benefits are valid until terminated or cancelled by Pretty's Prime Cuts (in its absolute discretion) or until the Cardholder notifies Pretty's Prime Cuts customer service via email [natalie@prettysprimecuts.com.au](mailto:natalie@prettysprimecuts.com.au), that he or she wishes to terminate their Card. If a Card is terminated the Cardholder must return the Card by hand to a Pretty's Prime Cuts store.
13. Pretty's Prime Cuts is not responsible for stolen or lost Cards or Cards that are used fraudulently. The Cardholder must report a stolen or lost Card to Pretty's Prime Cuts immediately. The Cardholder's existing Card will be cancelled and a new Card issued.
14. To the fullest extent permitted by law, Pretty's Prime Cuts gives no warranty and shall have no liability in respect of goods or services provided to Cardholders or as to the accuracy of any description or information about such goods or services, even though Pretty's Prime Cuts may have notified the Cardholder of those goods or services.
15. Pretty's Prime Cuts makes no warranty or representation as to the quality, suitability or merchantability of any goods or services offered as prizes.
16. Cardholders indemnify Pretty's Prime Cuts for and against any loss or claim suffered or incurred by Pretty's Prime Cuts arising from or in connection with a breach of these Terms and Conditions by a Cardholder.
17. Pretty's Prime Cuts reserves the right to:
  - Suspend or terminate the Card at any time and without prior notice; and
  - Vary these Terms and Conditions at any time for any reason and without notice to Cardholders.
  - For the avoidance of doubt, these Terms and Conditions supersede and replace any and all previous Terms and Conditions specifically governing the Programme.
